

TERMS AND CONDITIONS

BLUEGRASS DOWNS (A SUBSIDIARY OF CAESAR'S ENTERTAINMENT, INC.)

1. Horsemen will be allotted stalls with the understanding that their horses are ready to race. Bluegrass Downs reserves the right to ask horsemen to leave the property if they do not enter their horse or horses in a race that is available for that horse to race in.
2. The Racing Secretary can revoke stall space if any one of these conditions apply:
 - A) If a horse is substituted for another horse without prior permission.
 - B) If stalls are not occupied by the time the race meet starts.
 - C) If no effort is made to enter that particular horse.
 - D) If a trainer loans out stalls that are assigned to him.
 - E) If a horse is sold or transferred during the race meet.
3. All owners, trainers and drivers, or any employee of these shall obtain a license from the Kentucky Horse Racing Authority, and shall abide by all rules of that organization.
4. All stalls shall be cleaned on a daily basis and shall be left clean when vacated. ONLY WOOD SHAVINGS ALLOWED IN STALLS (NO STRAW ALLOWED.) A \$20.00 cleanup fee will be assessed if stalls are left dirty when vacated.
5. Any and all Drivers are required to wear a safety helmet while on the racetrack.
6. The association reserves the right to require eight (8) horses in any race. In the event eight (8) horses do not enter, the race may be called off or another race scheduled.
7. A negative Coggins test dated within the last 12 months must accompany each horse coming to Bluegrass Downs. (NO COGGINS---NO ADMISSION) All out-of-state horses must have a current Health Certificate. **ALL HORSES MUST HAVE A NEGATIVE TEST FOR EQUINE PIROPLASMOSIS!**
8. Bluegrass Downs will not be liable for loss, injury or damage sustained by the owners, trainers, drivers or horses participating in activities engaged in, on the premises owned or controlled by Caesar's Entertainment, Inc.. Owners and Drivers assume full responsibility for their acts and the acts of their agents, servants and employees in connection with all activities in which they engage in while on the property owned and controlled by Caesar's Entertainment, Inc.
9. NO CAMPERS, DOGS OR CATS ALLOWED IN THE BARN AREA
10. Bluegrass Downs reserves the right to refuse stall space and/or deny access to the back side facilities to any individual should the Administration deem it necessary.
11. In the event of a dispute involving the above conditions, or in the event of any special or unforeseen occurrences not covered in these conditions, the decision of Bluegrass Downs will be final.
